- 1. New commercial buildings.
- 2. New multi-family projects (over two units).
- 3. Installations or alterations of any commercial or multi-family electrical service, sub panel, transformer, UPS system or generator. (Alterations include any increase in calculated load of 100 amps or greater.)
- 4. Installations or alterations in hazardous (classified) locations as defined by N.E.C.
- 5. All work on electrical systems operating over 600 volts.

Note: Plans need not be submitted for work inside a single multi-family unit unless it affects fire rated walls.

Plans are not required for temporary electrical service 200 amps or less.

DESIGN BY A REGISTERED ELECTRICAL ENGINEER IS REQURIED FOR THE FOLLOWING:

- 1. All services rated 1600 amperes or larger, or any special considerations to the service.
- 2. Anything that requires engineering supervision by the N.E.C.
- 3. When the Building Official feels that it is warranted, based on the complexity, hazard, NEC compliance, or other unique aspects of the proposed design.

SUBMIT THREE COPIES OF THE FOLLOWING FOR ELECTRICAL PLAN REVIEW:

- □ Electrical plans or drawings. (Minimum plan size is 18"x 24" with 1/8" scale, ¼" scale for details)
- Q Electrical plans sealed and signed by a registered electrical engineer.
 - i. Note that the Village of Pontoon Beach has local Electrical Code Amendments.
- □ Electrical plans showing power and lighting for each floor and the location of all electrical panel boards.
- □ Electrical panel schedules with loads indicated in volt-amperes (VA) or kilovolt-amperes (KVA) and listed interrupting rating (A.I.C.) of all over current protective devices.
- Riser diagram showing the point-to-point available fault current and the raceway size and type, the conductor's size and type, and grounding methods. Include a detail of the grounding electrode system.
- O Complete electrical loads calculations, including an electric load summary showing all applicable demand factors.
- © Complete fault current calculations, through the panel board level or provide sufficient information to verify fault current calculations.
